Section 301 – China Origin Tariffs

Section 232 – Steel & Aluminum Tariffs; Multiple Countries

Steel

25% (50% from Turkey as of Aug 13, 2018)

For the purposes of this proclamation, “steel articles” are defined at the Harmonized Tariff Schedule (HTS) 6-digit level as, including any subsequent revisions to these HTS classifications:

- a) **7206.10 through 7216.50**
- b) **7216.99 through 7301.10**
- c) **7302.10**
- d) **7302.40 through 7302.90**
- e) **7304.10 through 7306.90**

Aluminum

10%

For the purposes of this proclamation, “aluminum articles” are defined in the Harmonized Tariff Schedule (HTS) as, including any subsequent revisions to these HTS classifications:

- a) unwrought aluminum (HTS **7601**)
- b) aluminum bars, rods, and profiles (HTS **7604**)
- c) aluminum wire (HTS **7605**)
- d) aluminum plate, sheet, strip, and foil (flat rolled products) (HTS **7606 and 7607**)
- e) aluminum tubes and pipes and tube and pipe fitting (HTS **7608 and 7609**)
- f) aluminum castings and forgings (HTS **7616.99.51.60 and 7616.99.51.70**)

IMPORTANT NOTE: these Sec 232 tariffs are in addition to current tariffs/duties including **Antidumping and Countervailing Duty**. There are several cases currently active for steel and aluminum products.
